What is the NORD® Living Rare Living Stronger® Patient and Family Forum?

Living Rare Living Stronger (LRLS) is an annual patient-focused conference providing people living with rare diseases and their families with practical tools for living their best lives with rare diseases. We offer sessions with perspectives from patients, caregivers and the healthcare professional community.

When is the event and who can attend?

LRLS 2022 will be held Sunday, June 26, 2022 at the Intercontinental Cleveland Conference Center in Cleveland, Ohio and everyone is welcome to attend!

What does it cost to attend?

The Living Rare Forum is free of charge for patients and caregivers! The full event pricing details can be found on the event <u>website</u>. There are also several options available to apply for lodging or travel assistance.

Money is tight, are there any opportunities for support in order to attend?

NORD offers many scholarships to offset the costs of travel and lodging associated with attending LRLS. Please be sure to fill out a sponsorship application – Visit the <u>website</u> for more information and application deadlines.

Is the event in-person or virtual?

2022 Living Rare, Living Stronger will mark the first time in more than two years that NORD is hosting an in-person event. Your support is critical to NORD's ability to convene our community so that all attendees may participate in engaging sessions and networking opportunities in a safe, comfortable environment. NORD is committed to the health and safety of all attendees. NORD is abiding by local, state and national guidelines, which are updated as needed, so please visit our website for the latest information on the Forum's health and safety protocols. A virtual option is now available for those who are unable to join us in-person.

I want to attend but can't visit Cleveland; are sessions recorded?

Sessions will be available via a live-stream virtual option and are also being recorded. Registration will include on-demand access for all content after the program concludes. All participants will be notified by email with details how to view.

Will CME credits be available?

At this time, the Living Rare, Living Stronger Forum is not accredited for CME credits. Though health care professionals are invited, all program content is for a patient and caregiver audience.

HEALTH AND SAFETY GUIDELINES

Attendees should be aware that while the Living Rare Forum and Rare Impact Awards are taking place we will make every effort to reduce the risk of COVID-19 transmission, it is possible that attendees will come in contact with people in airports, on public transportation, and in other public areas with individuals who could potentially carry the virus, which is why NORD strongly encourages those, who are able, to be fully vaccinated for their own safety, as well as the safety of others ahead of attending the event.

At this time, ALL attendees of the Living Rare Forum featuring the Rare Impact Awards must be fully vaccinated against COVID-19 prior to arrival in Cleveland or have received a negative PCR or antigen (rapid) COVID-19 test within 24 hours of picking up their registration badge at the conference venue. If you cannot or choose not to comply with NORD's health and safety protocols, we hope to provide you with other ways to enjoy the program at a later date.

Proof of vaccination or a negative COVID-19 test may be submitted via an email with a link to a secure, HIPAA-compliant verification site ahead of the conference. More information on that will follow your registration for the event. NORD staff will have no access to the information submitted via the verification site; NORD will only receive notification that the attendee has or has not completed the verification process.

*** COVID VERIFICATION MUST BE SUBMITTED PRIOR TO ARRIVAL, NO COVID DOCUMENTS WILL BE ACCEPTED ONSITE***

In addition, it is mandatory for ALL persons within the meeting and event spaces to wear a face mask covering BOTH their nose and mouth at all times while they are indoors. This includes attendees and all accompanying persons above the age of two (2).

By attending Living Rare, Living Stronger featuring the Rare Impact Awards 2022 in person, you are confirming that you:

- Are fully vaccinated or have received a negative PCR or antigen COVID-19 test within 24 hours of picking up your registration badge at the conference venue;
- Are not experiencing any symptoms of COVID-19 identified by the Centers for Disease Control and Prevention at CDC.gov;
- · Are not under any self-quarantine orders; and
- Acknowledge and will abide by all applicable regulations and health and safety protocols.

If you will not be fully vaccinated by the time of Living Rare Forum and Rare Impact Awards and are registered for the LIVE meeting, you may cancel your registration and watch the recorded content when it becomes available shortly after the program.

OFFICIAL NATIONAL / STATE GUIDELINES

NORD will comply with all state and federal requirements, and NORD reserves the right to modify or eliminate the option of negative testing at any time should federal or state mandates change.

Fully vaccinated means that either three weeks have passed since receiving the second dose of an FDA- or WHO-authorized double-dose COVID-19 vaccine or that three weeks have passed since receiving the one dose of an FDA-or WHO-authorized single-dose COVID-19 vaccine.

Booster shots are strongly <u>recommended</u> by the CDC if it has been more than five (5) months after completing the primary COVID-19 vaccination series.

NORD is committed to maintaining the health and safety of all Living Rare Forum and Rare Impact Awards attendees, and the latest <u>Centers for Disease Control and Prevention</u> and <u>World Health Organization</u> guidelines as well as industry best practices will be followed as closely as possible. NORD will be coordinating with the venue spaces, the InterContinental Cleveland Conference Center and Rock Hall, to actively monitor local conditions, risk factors, and any applicable laws, regulations, and guidance. Because these factors are frequently changing, this page will continue to be updated as new guidance is released.

ADDITIONAL HEALTH & SAFETY GUIDELINES

No Onsite Registration

- Due to requirements to submit proof of vaccination and negative test results PRIOR to ARRIVAL at Living Rare, Living Stronger featuring the Rare Impact Awards 2022, there will be NO ONSITE REGISTRATION for Living Rare, Living Stronger featuring the Rare Impact Awards 2022.
- Please plan to register well in advance, to allow for the HIPAA-compliant COVID screening and approval process to be completed prior to your arrival.

Testing

- NORD is unable to provide resources for on-site COVID-19 testing on arrival, or prior to departure for attendees. Please complete your COVID-19 screening test prior to arrival at the Living Rare Forum and Rare Impact Awards. NORD is not able to provide COVID-19 testing, you are required to make your own arrangements.
- For information on testing locations, contact your state or local government, or your health care provider to determine the options available for testing in your area.

Venue and Hotel

- The InterContinental Cleveland Conference Center will be monitoring and following the CDC, WHO, and local health department's guidelines. Please visit the <u>InterContinental Cleveland Conference Center website</u> and view <u>IHG Hotels & Resorts Way of Clean</u> website for detailed information about the steps IHG is taking to protect meeting attendees.
- Meeting room set up will be coordinated and planned with appropriate social distancing. Please note that social distancing guidelines may continue to change and evolve based on direction from the CDC and the state of Ohio. The InterContinental Cleveland Conference Center and NORD are committed to full compliance and safe social distancing in all meeting areas.

Masks

- At this time, the wearing of protective masks is required of all attendees, faculty, and staff, regardless of whether or not it is required by law at the time of the meeting.
- Masks must be worn properly (covering both mouth and nose) at all times indoors, except as noted below. The indoor mask requirement applies to all indoor areas of the InterContinental Cleveland Conference Center and Rock Hall. Masks are not required outdoors.

- Masks may be removed briefly in the following situations:
 - > When actively eating or drinking.*
 - > When speaking at the lectern (as the distance between the speaker and audience will be greater than six feet). Speakers should put their masks back on when not actively presenting.
 - > When being photographed or interviewed on camera by registered media or staff.*
 - > *PLEASE NOTE: Attendees should maintain a distance of at least six (6) feet from others when unmasked in the above-mentioned situations if possible. Food and beverages will only be permitted in designated areas.
- While surgical masks and additional cloth masks will be provided on site, attendees are welcome to bring their own mask of choice. Surgical, N95, and KN95 masks are strongly preferred. Gaiters, bandanas, and masks with exhalation valves will not be accepted.
- Attendees who are not properly masked will be refused admittance to sessions and events and may have their badges revoked. <u>Please see CDC guidance on masking</u>.
